Adoption Week Scotland 19th - 23rd November 2018

AFA Scotland and Adoption UK have been successful in their joint bid to develop and deliver a programme of events for Adoption Week Scotland in 2018 and 2019. Form F Update (adoption and permanence)

A small working group has been established to draft a revised version of the Form F. It is anticipated that the text for the revised template will be completed by the end of the year. The timescale for making this available to agencies will be dependant on the publication schedule with Coram/BAAF.

Newly developed courses "Bump Into Meetings"

AFA Scotland invites professionals to come to a session on 15 November 2018 in Edinburgh that will 'throw the spotlight' on to certain new ways of working.

It will allow those attending to explore the concept of 'Bump Into' meetings with Rhian, who devised and promoted the concept, Elaine, who authored the CoramBAAF Practice Note 64: Best Practice in meetings between prospective adopters and children prior to matching on the concept, and Kate, Fiona and Robin who have encountered the practice from differing angles while engaged with cross border adoption placements.

We are in a changing practice landscape, beset by competing interests and resource considerations. This session aims to contribute to a dialogue about ensuring that permanence processes in Scotland are informed, considered and retain the best interests of the child as their paramount concern.

Moving Images

This project, funded by the *Big Lottery Awards For All* and *University of Glasgow's Knowledge Exchange Fund*, is exploring the use of videos or other 'moving images' in the family finding and matching process within adoption. It is being carried out by the University of Glasgow and AFA Scotland, supported by Scotland's Adoption Register.

The process involved in finding the best possible match between a child identified as requiring adoption, and prospective adoptive parents is unusual - this is not something that families in other circumstances have to be involved in. This project considers the extent to which creating videos of the children can help to inform this critically important decision and ensure the best possible match is found for each child. Through surveys and interviews with adopters, social workers and foster carers, many stories emerged of the way in which these videos helped communicate a real sense of the child, alongside the information shared in more conventional written profiles.

A resource pack will be produced by the end of the year to provide advice and guidance to social workers and foster carers where the possibility of making a video is being considered. The pack will provide advice about how to approach the process, how best to communicate a true picture of the child on film, the technical aspects of making, editing and storing videos, and the legal and data protection issues involved.

The findings of the project will be presented at two free ticketed workshops on Tuesday 4th December (Edinburgh) and Friday 7th December (Glasgow). Further details on these events will be forwarded to agencies.

Adverse Childhood Experiences (ACE's)

Adverse Childhood Experiences have been widely discussed and interpreted in terms of meeting children's needs. They also have relevance for adults reflecting on their histories; the approach however is not without controversy. A workshop is scheduled for 20 November 2018 in Edinburgh which will aim to explore the relevance of ACE's in relation to the assessment of prospective adopters and foster carers. It will be facilitated by Ravinder Kaur.

Events Update

Legal Conference - 22 June 2018

Adoption, Permanence Orders and Kinship Care finding the best options for our children

This conference was delivered with a high standard of speakers, knowledge and fun. We heard from The Honourable Lady Wise, Judge of the Supreme Courts whose incisive summation of the Court's approach to permanence decisions was gripping. John Simmonds OBE, Director of Policy, Research and Development, CoramBAAF, provided a far reaching overview on the subject in which he is a world expert. Our own members, Roger Mackenzie, Associate, Digby Brown and Leigh Jolly, Social Work Manager, Corporate Parenting, Aberdeenshire Council demonstrated why they are so well respected in their fields with invaluable descriptions of how they discharge their professional duties. Shona Spence helpfully talked us through Scottish Government policy and the final input from 2 kinship carers was both insightful and moving. The proceedings were presided over by the chair and compere, Lynda Brabender QC who kept us informed and amused in equal measure. There was again a huge turn out of delegates from all disciplines who took full advantage of the opportunity to catch up with each other. Thank you to everyone involved in this wonderful day. We will meet again in Dundee on 14 June for our 2019 Conference.

<u>Health Group Conference - 28 September 2018</u> More than the sum of their parts - responding to the complexity of our looked after and adopted children
