

AFA Scotland Free Prize Draw Terms and Conditions

1. By entering the prize draw you are agreeing to these prize draw terms and conditions.
2. The prize draw is being run by the Adoption and Fostering Alliance Scotland (AFA Scotland), Foxglove Offices/GF2, 14 Links Place, Edinburgh, EH6 7EZ.

Eligibility to enter

3. The prize draw is open to entrants over 18 years of age and employed within the kinship, adoption and fostering sector (staff members of AFA Scotland, Scotland's Adoption Register, Kinship Care Advisory Service Scotland and CoramBAAF are excluded from the draw).
4. In entering the prize draw, you confirm that you are eligible to do so and eligible to claim any prize you may win.
5. A maximum of one entry per individual is permitted.
6. The prize draw is free to enter.

How to enter

7. The prize draw will include those who provide their email address at the end of the AFA Scotland Survey, confirming they would like to be included in the prize draw.
8. Entries must be received by 17:00 BST on 24 September 2021. Entries after that time and date will not be included in the draw. AFA Scotland accepts no responsibility for any entries that are incomplete, illegible, corrupted or fail to reach us by the relevant closing date for any reason. Automatically generated entries and entries via agents or third parties are invalid and shall not be considered.
9. To enter the prize draw, simply complete the AFA Scotland Survey.

The prize

10. The prize is admission for one (1) person to their choice of either (1) the upcoming Legal Conference (5 Nov, 2021), or (2) any workshop run by AFA Scotland up to 31 March 2022.
